Introduction

This directory provides a list of the plan's network providers. Depending on your plan, you may receive certain covered services from out-of-network providers that accept the plan. You do not need a referral to see in or out-of-network providers for covered services. To get detailed information about your health care coverage, please see your Evidence of Coverage.

What is a primary care provider?

A primary care provider (PCP) is the health care professional who provides most of your care. The term PCP will be used throughout this directory.

Your PCP can help you:

- Make smart lifestyle choices to help improve and maintain your health
- Get preventive care and health screenings
- Better understand your medical conditions
- Coordinate any specialist care to help avoid duplicate and expensive tests
- Manage your prescriptions and identify possible harmful interactions

Select a primary care provider

To make sure you get the care you need, choose one of our network providers to be your primary care provider (PCP). However, you're not limited to this PCP for all your primary care.

If you choose a PCP who is not taking new patients, we may assign you to a different PCP. If this happens, you can switch to another PCP who is accepting new patients.

Your PCP plays an important role in your health care, and we want you to be comfortable with the provider you choose. If you want to switch providers, call Customer Service toll-free at **1-844-368-6885**, 8 a.m.-8 p.m.: 7 Days Oct-Mar; M-F Apr-Sept, TTY **711**.

The difference between network and out-of-network providers

Network providers are providers that your plan works with to give you care. If you use a network provider, your out-of-pocket costs, which are costs paid by you, may be lower. Out-of-network providers are providers that we currently do not work with, so your out-of-pocket costs may be higher.

The network providers listed in this directory have agreed to provide you with your health care coverage. You can see a network specialist or other network provider without getting a referral. Depending on your plan, you may be eligible to receive certain covered services from out-of-network providers. Check your Evidence of Coverage to see which services may be covered out-of-network.

If I need emergency or urgent care

A **medical emergency** is when you believe that you have symptoms that require immediate medical care to prevent death, loss of a limb, or loss of function of a limb. The medical symptoms may be an illness, injury, severe pain, or a medical condition that is quickly getting worse.

If you have a medical emergency, get help as quickly as possible. Call 911 or go to the nearest emergency room or hospital. Emergency care can always be obtained in or out of the service area from the nearest available provider. Emergency services are also covered whether a provider is in our network or not. You or someone else should call and tell us about your emergency care, usually within 48 hours.

Urgently needed services are for non-emergency, unforeseen medical illness, injury, or condition, that requires immediate medical care. When out of the service area, urgent care may be obtained from the first available provider whether the provider is in our network or not. In addition, when out of the service area, you can get dialysis treatment from any qualified dialysis provider.

Out-of-network/non-contracted providers are under no obligation to treat plan members, except in emergency situations. Please call Customer Service number or see your Evidence of Coverage for more information, including the cost-sharing that applies to out-of-network services and which out-of-network services may be covered.

If you get a bill

There may be times when you get a bill from a provider for the full cost of medical care you have received. If you get a bill, contact us. In many cases, you should send this bill to us instead of paying it. We will look at the bill and decide whether the services should be covered. If we decide they should be covered, we will pay the provider directly. Please see your Evidence of Coverage for more information.

If you're on Medicare and Medicaid

If you're a Qualified Medicare Beneficiary (QMB), your doctor may not bill you for deductibles, copays or coinsurance for Medicare-covered services, except for Part D prescription drug copays. Please show your UnitedHealthcare UCard® and your state-issued Medicaid member ID card when you see the doctor or use other plan services. This will help ensure you're billed for the correct amount.

Telehealth (Virtual Visits)

Telehealth, also known as virtual visits, is covered under your benefit plan. You can access telehealth services from any network provider that offers virtual care. Telehealth services may include primary care, specialist care, physical therapy, occupational therapy, speech therapy, cardiac rehabilitation, urgent care and/or behavioral health care. Not all network providers offer virtual care and those that do may not offer it for all services indicated. Not all medical conditions can be treated through telehealth. Your provider may tell you that you need to see an in-person doctor for treatment. To access your telehealth benefits, ask your local network provider if they offer virtual care or look for the telehealth indicator listed next to a provider's name within this directory.

Accessing your behavioral health benefits

To access your behavioral health benefits, call the toll-free Customer Service number on the cover of this directory. When you call, a representative will check your eligibility and get basic information about you and your situation. If you prefer, your PCP may call and arrange a referral for you. Your personal information will be kept strictly confidential.

Organ transplant services

Your plan has a network of facilities that perform organ transplants (including heart, lung, liver, intestine, kidney, bone marrow and/or pancreas). Solid organ transplants must be performed at a facility that is currently Medicare-approved for your specific type of transplant. The plan's hospital network for organ transplant services is different than the network shown in the **Hospitals** section of this provider directory. Some hospitals in the plan's network for other medical services are not in the plan's network for transplant services. The complete list of Medicare-approved facilities in your plan's network may change throughout the year. For information on network facilities for transplant services, please call Customer Service toll-free at **1-844-368-6885**, TTY **711** or refer to the transplant vendor website information listed in the **National Vendors** section of this provider directory.

Hospital, ancillary and urgent care/surgicenter listings

Your plan's network includes both ambulatory surgical centers and outpatient hospitals. Depending on the kind of facility you choose, your share of the cost may vary. You will generally pay less at ambulatory surgical centers. See your Evidence of Coverage for more information.

Wait times for primary care and behavioral health

UnitedHealthcare must provide you with access to primary care and behavioral health services within the following time frames:

- Immediately for urgently needed services or an emergency.
- Within seven (7) days for services that are not an emergency or urgently needed, but you require medical attention.
- Within thirty (30) days for routine and preventive care.
