

Instructions to Qualify for Advantage-level Benefits

Adults (Age 18 and Over)

In order to qualify for Advantage-level benefits (beginning at enrollment) in the UnitedHealthcare Pledge PlanSM, a HEALTHpact plan, each adult (age 18 and over at the time of enrollment) must complete the following:

1. Member Pledge Form

Every adult must complete and submit the enclosed Member Pledge Form **21 days** prior to the enrollment date. The enrollment date is the date your coverage begins.

2. Employee Enrollment Form: Physician Section

A Primary Care Physician (PCP) must be designated for every adult in Section B of the Employee Enrollment Form **21 days** prior to the enrollment date.

3. Health Risk Appraisal Form

Every adult must complete and submit the enclosed Health Risk Appraisal Form **21 days** prior to the enrollment date.

Adolescents (Ages 12 to 17)

In order to qualify for Advantage-level benefits (beginning at enrollment) in the UnitedHealthcare Pledge PlanSM, a HEALTHpact plan, each adolescent (who is at least 12 but not older than 17 at the time of enrollment) must complete the following:

1. Member Pledge Form

Every adolescent must complete and submit the enclosed Member Pledge Form **21 days** prior to the enrollment date. The enrollment date is the date your adolescent's coverage begins.

2. Employee Enrollment Form: Physician Section

A Primary Care Physician (PCP) must be designated for every adolescent in Section B of the Employee Enrollment Form **21 days** prior to the enrollment date.

Note: The Health Risk Appraisal Form is not required for adolescents.

Children (Under Age 12)

In order to qualify for Advantage-Level benefits (beginning at enrollment) in the UnitedHealthcare Pledge PlanSM, a HEALTHpact plan, each child (who is under 12 at the time of enrollment) must complete the following:

1. Employee Enrollment Form: Physician Section

A Primary Care Physician (PCP) must be designated for every child in Section B of the Employee Enrollment Form **21 days** prior to the enrollment date. The enrollment date is the date your child's coverage begins.

Note: The Member Pledge Form and Health Risk Appraisal Form are not required for children under 12.

Mail no later than 21 days prior to enrollment. If we do not receive of these forms from each family member, as required, the entire family shall receive Basic-level benefits.

Saturday, March 1, 2008	→	Monday, February 11, 2008*
Tuesday, April 1, 2008	→	Tuesday, March 11, 2008
Thursday, May 1, 2008	→	Thursday, April 10, 2008
Sunday, June 1, 2008	→	Monday, May 12, 2008*
Tuesday, July 1, 2008	→	Tuesday, June 10, 2008
Friday, August 1, 2008	→	Friday, July 11, 2008
Monday, September 1, 2008	→	Monday, August 11, 2008
Wednesday, October 1, 2008	→	Wednesday, September 10, 2008

*The 21st day prior to the December, March and June dates falls on a weekend day and, therefore, has been advanced to the next Monday.
