### **Covered diabetic supplies**

Your UnitedHealthcare Colorado Options Individual & Family prescription drug plan covers diabetic supplies at no cost to you, not subject to a deductible, when filled at a network pharmacy. Applicable formulary requirements such as prior authorization and quantity limits may apply.

#### Frequently asked questions

#### Which diabetic supplies are covered by my Colorado Options Individual & Family medical plan from UnitedHealthcare?

In addition to prescription coverage, your plan's medical benefit may also cover some diabetic supplies, like continuous glucose monitors, at \$0 cost-sharing. All forms of continuous glucose monitors are provided when clinical guidelines are met and when obtained from sources designated by your health plan. Insulin pumps and insulin pump supplies are provided when clinical guidelines are met and when obtained from sources designated by your health plan. Call the phone number on your health plan ID card for more information.

### What if my diabetic supply is not covered?

If your healthcare provider (doctor, nurse practitioner, etc.) determines you need a diabetic supply that is not covered by your plan, they can let us know it is medically necessary and provide information about your diagnosis and treatment history. If the request to cover a non-covered diabetic supply is approved, you will pay a \$0 cost-share, not subject to a deductible.
